### Silver Alert

The most critical moments during the search of a missing person are the first few hours immediately following the discovery of their disappearance.

The Silver Alert program uses broadcast media and state resources (TV, Radio and road message signs) to alert the public that a cognitively impaired individual is missing.

The Silver Alert can be activated for any cognitively impaired individual, regardless of age.

A cognitively impaired individual is defined as *“a person having a deficiency in his or her short-term or long-term memory, orientation as to person, place, and time, deductive or abstract reasoning, or judgment as it relates to safety: Provided, That the cognitive impairment is not caused by the use of alcohol or drugs not legally prescribed by a physician.”*
