

Sunday, March 10, 2024

The 2024 Regular Session concluded midnight Saturday. In total, **280** Bills (*123* House Bills, *157* Senate Bills) completed legislative action. Below is a preliminary summary of key bills for hospitals and health care. Thanks to the hospital community for your grassroots support and for helping achieve the passage of legislative priorities for the WVHA. Playing defense on numerous bills introduced in the Legislature (primarily in the House) was also a top priority and we could not have accomplished this goal without your grassroots support. HB 5157 DPP Bill signed by the Governor - WVHA Priority

The Governor last week signed <u>HB 5157</u>- the Facility Directed Payment Program (DPP). As we've noted throughout session, this is enabling legislation which removes the static tax rate on the DPP Program and allows the hospitals to assess themselves at the maximum rate allowed by CMS. This bill also expands hospitals eligible to participate in the Program from 23 up to approximately 57 hospitals, including critical access hospitals. Look for additional information soon from WVHA on the State Plan Amendment (SPA) process and our working with the State Medicaid office for implementing the provisions of HB 5157.

340B legislation completes legislative action - WVHA Priority

SB 325 is the 340B protections bill we've been advancing this session. On Friday, it completed legislative action following the bill's passage in the House by a vote of 96-1 with no changes. It's now on the Governor's desk for signature. During House floor debate, there was a motion by Delegate Amy Summers to delay the effective date to January 1, 2025, instead of the normal 90 days from passage. Her motion failed 14-83. This is the bill that prevents pharmaceutical companies from implementing policies that restrict our hospitals' ability to utilize contract pharmacies under the federal 340B program. We'll be working with our partners to distribute a joint letter of support/request for the Governor to sign this bill into law.

Anti-doxing bill completes legislative action – WVHA Priority

SB 477 is our Anti-Doxing bill which completed legislative action this week. This bill applies to all health care workers including those in governance positions along with first responders (like law enforcement, EMS, and firefighters). The bill now heads to the Governor for his signature. There are two parts to the bill: **1)** aims to criminalize making the personal information of a health care worker and first responder, or their immediate family, publicly available on the internet with the intent to threaten or incite the commission of a crime of violence; and **2)** provides a process for a health care worker/first responder to submit a written request to a state or local government to remove personal information from records available on the internet - if he or she believes the personal information contained in the records poses an imminent and serious threat to the person's safety or the safety of the person's immediate family.

<u>SB 17 – Department of Health Rule and Hospital Licensure completes legislative action WITHOUT</u> harmful hospital language

In the final hours of the session, the WVHA successfully removed an amendment to **SB 17** which is the Department of Health Rules Bill that contained an amendment to the Hospital Licensure Rule re: hospital reporting of quality data. On Saturday morning, the Senate removed the reporting language and sent the bill back to the House for consideration. The House agreed to the Senate change <u>90-5</u> but not before remarks were delivered on the House Floor by Delegates Amy Summers and Heather Tully disagreeing with the changes made in the Senate. The bill was then passed by the House <u>94-1</u>. The bill completed legislative action *WITHOUT* any burdensome and duplicative language for hospitals relating to reporting of quality data.

HB 5105 – Immunization bill completes legislative action, now on to the Governor

Late Saturday, the Senate passed **HB 5105** – the immunization bill by a vote of <u>20-12 with 2 absent</u>. Because the Senate amended the bill, it had to go back to the House for consideration and voted on again. The House vote was <u>70-29 with 1 absent</u>. In summary, this bill would allow private and parochial schools to develop their own policies for immunizations and provide them legal protections for those choices. The bill also allows vaccine exemptions for students attending virtual public schools. Students who participate in West Virginia Secondary School Activities Commission-sponsored activities outside of their school would still be required to be vaccinated. The bill also clarifies that if a student is attending some virtual school and some in-person school, the student should follow the requirements of the in-person school. The final language approved is available here.

Various CON bills do not advance this session

Several bills were introduced in the Legislature this session impacting the Certificate of Need (CON) program. Earlier this session, **HB 4909 (CON Repeal)** was advanced to the full House by the House Health Committee 13-9. HOWEVER, the bill was immediately placed on the House's "inactive" Calendar, and it died on "crossover day." Other CON bills did not advance this session including bills that were either considered by the House Health Committee, passed the House; and/or died in the Senate Health Committee. These include some of the following we've been featuring this session:

- **HB 4408** Development of specialized intermediate care facility died in Senate Health Committee
- HB 4433 Mobile CT exemption bill died in Senate Health Committee
- HB 5286 Eliminating the ability to sub-contract under CON re: personal care services— died in Senate Health Committee

Bills directly impact hospitals complete legislative action

Two additional bills that completed legislative action impacting hospitals from a financial, clinical, operational, and regulatory perspective include, but are not limited to the following: Please note the passage of:

- **HB 4376** Relating to surgical smoke evacuation This bill states that on or before January 1, 2025, the Office of the Inspector General shall propose rules for legislative approval requiring a health care facility licensed under this chapter that utilizes energy generating devices to use a smoke evacuation system during any surgical procedure that is likely to produce surgical smoke.
- **HB 5014** Supplemental appropriation bill totaling \$6 million for hospital grants and research programs \$4 million for all hospitals to apply for grants and research programs and \$2 million to the West Virginia University Health System Federal Food and Drug Administration Pilot Program. Funding is from the Governor's Civil Contingent Fund
- SB 36 –Department of Homeland Security legislative rules (containing SANE hospital legislative rules previously approved requirements)

Other important hospital/health care provider related bills - complete legislative action

- SB 445 Reducing certification periods and renewal fees for EMS personnel
- SB 453 Requiring pricing and payment transparency from pharmacy benefits managers contracting with PEIA
- SB 533 Allowing EMS agencies to triage, treat or transport patients to alternate destinations

- SB 714 Transferring duties and licensing from Board of Osteopathic Medicine to Board of Medicine

Hospital and Health Care Bills Not Advancing

This session, we managed and played defense on several bills that would have placed additional administrative burden and costs on hospitals and the delivery system. Most of these bills <u>originated in the House</u> and the WVHA Legislative Team managed to keep many off the committee agenda or worked in the Senate to keep them from advancing. In the end, several we featured in our Updates and throughout the session ultimately did not advance. Below is a small sampling of bills that <u>DID NOT</u> complete legislative action:

- **HB 4320** Relating to access for minor children's medical records *died in Senate*
- **HB 5054** Relating to birthing centers died in Senate Health Committee
- **HB 5163** Relating to involuntary hold by law enforcement for a person determined to be an imminent danger *died in House Judiciary Committee*
- **HB 5254** –Relating generally to the creation of mental hygiene regions by the Supreme Court of Appeals died in Senate Judiciary Committee
- **HB 5297** Relating to prohibiting pubertal modulation and hormonal therapy when provided to assist in a gender transition *died in Senate Health Committee*
- HB 5361 Flu shots offered to hospital patients age 50 and older voluntarily based upon CDC recommendations - died in Senate Health Committee
- **HB 5530** Requiring a hospital to disclose price and fee information for certain health care services died in Senate Health Committee
- **HB 5647** MCO Tax died in Senate Finance Committee
- **HB 5685** Relating to Medicaid Cost Containment died in Senate Health Committee
- SB 791 Modifying membership of Medicaid Services Fund Advisory Council died in House

State Budget FY 2025

The Legislature approved the Fiscal Year (FY) 2025 Budget Bill (SB 200) and various supplemental appropriations to support state agency spending. The Budget Bill sets the general revenue budget for FY 2025 beginning July 1, 2025, at \$4.996 billion. Key features of the budget include: the passage of SB 841 - unemployment benefits bill; along with 5% pay raises for state workers (HB 4883) through general revenue funds, and the phasing out state taxes on Social Security (HB 4880). The pay raise bill provides pay increases for state workers whose pay scales are in state code. So, State Police personnel and public-school educators would be affected. That means State Police personnel would receive a \$2,900 annual salary increase. Teachers would receive a \$2,460 annual pay increase. And school service personnel would receive an additional \$140 a month. The estimated financial effect of fully eliminating income taxes on Social Security benefits would be a little more than \$37 million. The phase-out would mean a 35% cut retroactive to Jan. 1, 2024; 65% in 2025 and 100% in 2026. The legislation would build on a 2019 bill signed into law by the governor to exempt Social Security income from personal income taxes for most West Virginians, particularly those in lower tax brackets. That was also a three-year phase-out.

The WVHA Legislative Team will be evaluating the budget including the status of the Medicaid program and any associated line-items of importance to hospitals and health care. We want to be thorough in our analysis so please be on the lookout for information as soon as we have an opportunity to review the Budget in more detail. There's still some talk about a special session in May to round out some budget items, especially if some questions about state financial pressures can be resolved by then. Late last week, lawmakers learned the Governor's Office was in negotiations with the federal government over a potential \$465 million COVID-19 funding claw back related to the U.S. Department of Education. More to come as lawmakers evaluate revenue available to round out the FY 2025 since many proposals did not complete legislative action – including **HB 5647 the MCO tax** which was intended to fill a \$114 million hole in the Medicaid budget.

In the meantime, the WVHA Legislative Team will be producing a more detailed Legislative Summary in the coming days and weeks ahead. Also, we will be featuring the highlights of the 2024 Regular Session during a special WVHA sponsored online seminar call that we'll be scheduling in April.
