The West Virginia Legislature will begin next week Wed. Feb. 12 thru April 12. The WVHA Legislative Team will keep you informed of the action through various communications including our: WVHA Legislative Update; and any Call to Action and Alerts. - Update on CON Advocacy and Call to Action: WVHA will present its position in support of CON to the Joint Health Committee as part of interim meetings on Tue. Feb. 11 at 9:00 a.m. For more information on attending, please contact me and to stream the meeting visit here. WVHA presenters will be WVHA Board of Trustees Chair Skip Gjolberg, President, WVU Medicine St. Joseph's Hospital; and Vice Chair David Goldberg, President & CEO, Mon Health, and Executive VP, Vandalia Health. Other presenters include Justyn Cox, Executive Director, West Virginia Healthcare Authority, Matthew D. Mitchell, Senior Research Fellow, Knee Center. Jamie Cavanaugh, Legal Policy Counsel, Pacific Legal Foundation. Jessica Dobrinsky, Chief of Staff, Cardinal Institute. We're continuing our legislator outreach, and we know many of you have also joined in our efforts. Please keep us updated on any of your discussions with legislators.

- Health Care 101 Presentation: WVHA is scheduled to present a "Health Care 101" educational session for members of the <u>House Health Committee</u> next week, Thu. Feb. 13 at 3:00 p.m. Stay tuned next week for additional information about the presentation.

- Governor Patrick Morrisey and WV Legislature Priorities: Governor Morrisey will present his version of the State Fiscal Year (FY 2026) budget along with priorities during his first State of the State Address to a joint session of the Legislature on Wed., Feb. 12 at 7 p.m. Areas we're following include his position to repeal CON and comments about Medicaid and PEIA budget shortfalls. Also, Senate and House leaders appeared before the WV Press Association this morning to discuss legislative priorities. Some of the topics discussed included PEIA, the school aid formula, teacher pay raises and workforce development. Stay tuned early next week on more about the Governor's agenda and legislative leadership priorities.
- WV Senate and House Committee listings: Full WV Senate and House Committee announcements have been made so now we have a complete picture of which legislators are on committees. The Senate Health Committee will be chaired by Laura Wakim
 Chapman and the full membership is here. The House Health Committee will be chaired by Evan Worrel with full membership here.
