

Trainings

ICS-300 Intermediate Incident Command

Dec. 2-4, 2025 Morgantown, WV

This course builds on ICS 100 and 200 by teaching supervisors how to manage incidents that grow beyond their initial scope. It focuses on the National Incident Management System (NIMS) Command and Management components. Participants will learn roles and responsibilities for supervising during an expanding event. Register

ICS-400 Advanced Incident Command System for Complex Incidents

Dec. 11-12, 2025 Morgantown, WV

This advanced course is for senior emergency personnel who are expected to manage complex incidents. It expands on the information learned from ICS-110, 200, and 300. It covers large-scale organization development, roles, and relationships within command and general staff, and planning, operational, logistical, and fiscal consideration for major events. Register

MGT-318 Public Information in An All-Hazards Incident

Designed for participants whose duties may require them to interface with news media representatives during their community's response to a WMD/terrorism incident or major disaster. Threat Evaluation and Reporting Training Series

Dec. 12, 2025 Virtual - Register April 1, 2025 Charleston, WV – Register April 7, 2025

Morgantown, WV - Register

This is a 2-part series of courses sponsored by the WV Healthcare Coalitions North and South and presented by The WV Fusion Center. It is intended for the public and community members who play a role in identifying threats or observable behaviors that may concern others. Participants will learn tools to identify and report warning signs of violence in the workplace or community and ways to move the individual off the pathway to violence. Flyer

ICS 300 – Intermediate Incident Command System for Expanding Incidents

January 3-4, 2026

Martinsburg, WV

This course expands upon information covered in the ICS-100 & ICS 200 courses. This course is intended for individuals who may assume a supervisory role in expanding incidents or Type 3 incidents. Flyer

ICS 400 – Advanced Incident Command System for Complex Incidents

January 10-11, 2026

Martinsburg

This course builds on the ICS 100, ICS 200, and ICS 300 courses. However, it was designed to provide overall incident management skills rather than tactical expertise. Additional courses are available on developing and implementing incident tactics. Flyer

ICS 300 – Intermediate ICS for Expanding Events

January 26-28, 2026

Cleveland, OH

This 21-hour classroom course provides training for personnel who require advanced application of the Incident Command System (ICS) and Individuals who may assume a supervisory role in incidents. This course expands upon information covered in the ICS 100 and ICS 200 courses. Flyer

Medical Management of Chemical, Biological, Radiological, Nuclear and Explosive (CBRNE) Events

January 27-28, 2026

Morgantown, WV

Learn how to distinguish between different agents of concern that could be used in an incident. A combination of discussions, small-group exercises, human patient simulator hands-on scenarios, and traditional classroom discussions are used to present the topics. Flyer

MGT-319 Medical Countermeasures: Point of Dispensing (POD), Planning and Response

February 10-11, 2026

Morgantown, WV

This course is designed to enhance jurisdiction preparedness and emergency response efforts by providing knowledge of how to exercise and revise a plan that utilizes an all-hazards, whole community approach toward a medical countermeasures event. ICS 400 - Advanced ICS for Command and General Staff

February 23-24, 2026

Cleveland, OH

This 15-hour classroom course provides training for personnel who require advanced application of the Incident Command System (ICS). This course expands upon information covered in ICS-100, 200, 700, 800 and G300 courses, which are the prerequisites for the G400 course. The target audience for this course is senior personnel who expect to perform in management capacity in an Area Command or Multi-Agency Coordination Entity. Flyer
