### Lawmakers kick off legislative session

It's been a busy first 3 days of the legislative session with the introduction of <u>881 bills</u> in the Legislature. Many bills impact hospitals from a financial, clinical, regulatory, and operational standpoint. The WVHA Legislative Team will be reviewing these, and other bills introduced as the session unfolds. ### Status of CON / Call to Action

The week kicked off with a presentation on Certificate of Need (CON) to the interim Joint Health Committee. The Committee heard from WVHA, the Health Care Authority, Cardinal Institute, Pacific Legal and a Research Fellow from the Knee Regulatory Research Center. The recording of the meeting his here. The next day in his *State of the State Address*, Governor Morrisey called on the repeal of CON citing free market principals and expanding access to health care in rural communities. He said repealing CON will "fast track new private practices, urgent care, and other facilities." The Governor said the CON process is "big government activism at its worst" and, through repealing it, the state would "move toward the free market." His repeal bill was then promptly introduced in the Senate the next day as <u>SB 453</u> and single referenced to the Senate Health Committee. The Committee has not yet considered the legislation so please stay tuned for any committee activity. The Governor's companion bill in the House is expected to be introduced any day now.

With the Governor's comments along with a bill now introduced in the Legislature, we're requesting all member hospitals continue to engage in our support to protect and preserve CON. It's important that legislators hear from their local hospital constituents so please encourage your senior management staff to contact legislators. The impact on small rural hospitals and the communities they serve is of particular interest to legislators and that angle is supportive of our ongoing efforts on the ground. ### **Childhood Immunization**

The Senate Health Committee this week advanced <u>SB 460</u>, relating to childhood immunization requirements. The bill relates to <u>Executive Order 7</u> from the Governor - that the state allow religious and moral exemptions for school mandated vaccination requirements. The bill changes the process for getting a medical exemption to an immunization. Under the legislation, the state immunization officer position is eliminated, and medical exemption would be at the discretion of the child's physician. For a religious exemption, the parent would submit a written statement on a yearly basis saying that they object to one or more of the vaccinations on religious or moral grounds.

The committee voted down several amendments: one would have allowed private and parochial schools to develop their own vaccination policies independent of the state's requirements; the other would have required that families requesting religious exemption to specify which vaccine they have an objection to when submitting their exemption. Another amendment would have added requirements that schools and state-run day care centers report yearly the number of their students who have been granted exemptions for immunizations under each section of the legislation. The reporting requirements were in the original bill introduced by the Governor, but not the final committee substitute for the bill. SB 460 is on 1<sup>st</sup> reading in the Senate Monday. It's expected to sail through the Senate as early as Wednesday. A coalition of physicians, nurses and other health care providers are working through the <u>West Virginia Immunization Network</u> to advocate against the legislation.

# Governor's Budget

During the <u>State of the State Address</u>, the Governor presented lawmakers his bill (<u>HB 2026 and SB</u> 300) for a balanced general revenue budget – a revenue estimate of \$5.323 billion for fiscal year FY 2026 beginning in July. This comes after the Governor announced in January an estimated \$400 million hole in the upcoming budget year.

Since the *Address* on Wednesday, budget officials with the Governor's administration have been presenting an overview of his proposed budget bill to both the Senate and House Finance committees. Budget officials have continued to talk about a gap of nearly \$400 million created from a shortfall in revenues required to balance the budget. Morrisey's administration says they have made revenue adjustments, used one-time funds, and reduced expenses to make up this amount.

While many programs are budgeted with reductions from the current FY26 budget, it appears on initial review that the Governor's proposed budget fully funds Medicaid and the state's portion of PEIA. Please stay tuned on this as we learn more about proposed cuts and specific agency budgets as hearings are held in the Senate and House Finance committees in the coming weeks.

## Other Key Hospital Bills of Interest

While the focus these first few days has been on CON and the Governor's Budget, along with childhood immunizations, we want to alert you of a small sampling of key hospital bills of interest that have been introduced in the Legislature. - <u>HB 2044</u> Allowing an entity enrolled in PEIA to leave PEIA and have a 5-year window to return House Finance Committee
- <u>HB 2130</u> Relating to setting the rate the PEIA shall pay for services –House Finance Committee
- <u>HB 2173</u> Relating to requiring a hospital to disclose price and fee information for certain health care services House Health Committee
- <u>SB 164</u> Clarifying parent and guardian access to minor child's medical records Senate Health Committee
- <u>SB 286</u> Granting parents access to health records of minor child Senate Health Committee
